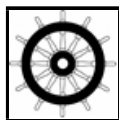

Application/Limitation

The life jacket is approved for infants with a weight of less than 15 kg and a height of less than 100 cm.

Retro-reflective material and position indicating light shall be approved in accordance with the Marine Equipment Directive (2014/90/EU) and bear the MED Mark of Conformity (wheelmark).

The design assessment is based on IMO Res. MSC.48(66) as amended by IMO Res. MSC.207(81), IMO Res. MSC.218(82), IMO Res. MSC.368(93) and IMO Res. MSC. 481(102).

IMO MSC/Circ.922 regarding thermal protective lifejackets (TP lifejackets) is not applicable for this type of life jackets.

Production testing shall be carried out according to IMO Res. MSC 81(70), Part 2.
